To All Whom These Presents May Concern:

## P. DENNIS FULBRIGHT AND MARGARET S. FULBRIGHT

(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagoe) in the full and just sum of

THIRTY THOUSAND NINETY EIGHT AND 92/100THS----- (\$ 30,098.92 \_\_)

Dollars, as evidenced by Mortgagor's promissory note of even date herewith, which note a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of Two Hundred Forty-

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and in-paid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagoe for such further sums as may be seed to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose:

NOW. KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor's necount, and also in consideration of the sum of Three Dollars (53.00) to the Mortgagor in hard well and truly paid by the Mortgagor at nell-before the scaling of these presents, the receipt whereof is bereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagor, its vaccessors and assigns, the following described real estate.

All that certain piece, pared, or lot of land, with all improvements thereon or beneafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, lying on the northwestern side of Edwards Road and being known and designated as Lot No. 67 of WADE HAMPTON TERRACE as shown on plat prepared by Dalton and Neves, dated March, 1955, recorded in the R. M. C. Office for Greenville County in Plat Book KK at page 15 and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Edwards Road at the joint front corner of Lots Nos. 66 and 67 and running thence with the line of said lots N. 18-51 W. 205.6 feet to an iron pin in the mar line of Lot No. 58; thence with the rear line of Lots Nos. 58 and 57 N. 71-09 E. 80.2 feet to an iron pin at the rear corner of Lot Nots. 68; thence with the line of said lot S. 21-35 E. 215.4 feet to an iron pin on the northwestern side of Edwards Road; thence with the northwestern side of said road S. 77-14 W. 90.5 feet to the beginning corner.
