ALL that piece, parcel or lot of land, situate, lying and being in the state of South Carolina, county of Greenville, in Austin Township, being shown and designated as Lot No. 22 on a plat of HOLLY TREE PLANTATION, PHASE II, SECTION 2, made by Piedmont Engineers and Architects, Surveyors, dated January 10, 1974, recorded in the RMC Office for Greenville County, S. C. in plat book 5-D, pages 47 and 48, and having the following metes and bounds, to-wit:
