MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and impaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Chatter of the Mortzagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall at the option of the holder thereof, become immediately due and payable and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

That the Mortgagor, in consideration of said debt and to scoure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars (53.00) to the Mortgagor in hand well and trily paid by the Mortgagor at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and Leinz in the State of South Carolina, County of Greenville, on the northwestern side of East Kenilworth Drive, being known and designated as Lot 40, KIngsgate, on a plat thereof made by Piedmont Engineering Service, 1/9/69, recorded in the RMC Office for Greenville County, South Carolina in Plat Book WAW, at Pages 44 and 45 and having according to said plat the following metes and bounds, to-wit:

Beginning at a point on the northwestern side of East Kenilworth Drive at the joint front corner of Lots 39 and 40 and running thence along the common line of said Lots N. 8-56 W. 144.4 feet to a point; thence N. 68-12 E. 44.4 feet to an iron pin; thence N. 31-44 E. 79.9 feet to a point; thence along the common line of Lots 40 and 41 S. 16-52 E. 196.5 feet to a point on the northwestern side of East Kenilworth Drive; thence along the said Kenilworth Drive S. 66-12 W. 79.2 feet to an iron pin; thence still with Kenilworth Drive S. 80-59 W. 45.8 feet to the point of beginning.
