"ALL that certain piece, parcel or lot of land with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, known and designated as Lot No. 10 of City View as shown on plat recorded in the RMC Office for Greenville County in Plat Book A, at Pages 460 and 461, and having, according to said plat, the following metes and bounds, to-wit;

BEGINNING at an iron pin on YMCA Street, 100 feet from the southwest corner of summitt street and YMCa street, and running thence along the line of Lot No. 9 N. 89 S. 150 feet to all ten foot alley; thence along said alley, S. 0-30 W. feet to an iron pin at corner of Lot No. 11; thence with line of Lot 11, S. 895 E. 150 feet to an iron pin on YMCa Street; and thence with YMCa Street. N. 0-30 E. 50 feet to the beginning corner.
