NOW THEREFORE, the Mortgagor, in consideration of the said debt and sum of money aforesaid, and for better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of \$3.00 to him in hand by the Mortgagee at and before the sealing and delivery of these presents hereby bargains, sells, grants and releases unto the Mortgagee, its successors and assigns, the following described real estate situated in Greenville County, South Carolina:

ALL that piece, parcel or lot of land situate lying and being in County of Greenville in the state of South Carolina and being known and designated as lot number 10 of the subdivision known as Riverdale and according to a plat being recorded in RMC office for Greenville County in Plat Book KK at page 107 and having the following courses and distance to-wit:

Beginning at an iron pin on the Western edge of Riverview Drive joint corner of lot 39 and 40 and running thence with the line of said lots North 76-06 West 249 feet more or less to an iron pin near the edge of Saluda River joint corner of lots 40 and 41 thence with the line of said lots North 87-36 East 299.3 feet more or less to an iron pin at the edge of Riverview Drive thence North 4-11 East 100 feet more or less to an iron pin to the point of the beginning

To provide and maintain fire insurance with extended coverage endorsement, and other insurance as Mortgagee may require, upon the building and improvements now situate or hereafter constructed in and upon said real property, in companies and amounts satisfactory to and with loss payable to the Mortgagee; and to deliver the policies for such required insurance to the Mortgagee.
- 4. In case of breach of covenants numbered 2 or 3 above, the Mortgagee may pay taxes, levies or assessments, contract for insurance and pay the premiums, and cause to be made all necessary repairs to the buildings and other improvements, and pay for the same. Any amount or amounts so paid out shall become a part of the debt secured hereby, shall become immediately due and payable and shall bear interest at the highest legal rate from the date paid.
