That the Mortzagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars (53.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant bargain, sell and release unto the Mortgagor its successors and assigns, the following described real estate:

All that piece, parcel or lot of land, situate, lying and being on the Eastern side of Third Day Street near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 40 as shown on a plat entitled "Canterbury Subdivision, Section II", prepared by Heaner Engineering Co., Inc., dated July 17, 1972, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 4-R at page 32 and as shown on a revision of said subdivision plat prepared by Heaner Engineering Co., Inc., revised through August 11, 1975, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 5-D at page 88 and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Eastern side of Third Day Street at the joint front corner of Lots Nos. 39 and 40 and running thence with the line of Lot No. 39 N. 88-50-09 E. 116.52 feet to an iron pin in the rear line of Lot No. 32 N. 00-35-52 E. 30 feet to an iron pin in the rear line of Lot No. 31 N. 00-35-52 E. 30 feet to an iron pin in the rear line of Lot No. 31; thence with the rear line of Lot No. 31 N. 12-28 W. 72.47 feet to an iron pin at the joint rear corner of Lots Nos. 40 and 41; thence with the line of Lot No. 41 S. 72-19-45 W. 120.17 feet to an iron pin on the Eastern side of Third Day Street; thence with the Eastern side of Third Day Street; thence with the curve of the Eastern side of Third Day Street, the chord of which is S. 09-32-22 E. 32 feet to the point of beginning.
