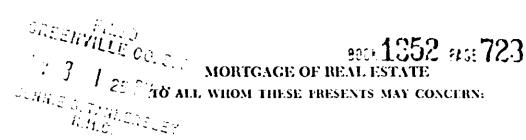

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be in lebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, burgained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed therein situate by in the State of South Carolina, County of Greenville, in Grove Township, approximately effecting (11) miles Southwest from the City of Greenville and containing 2.35 acres and being shown on Plat of Property of Erskine Cooley which plat was made by Webb Surveying And Mapping Company January, 1974 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at a point in the center of Bessie Road, joint corner with other property of the grantee and running thence through Bessie Road S. 48-38 E. 200 feet to a point and continuing through Bessie Road S. 55-42 E. 180 feet to a point which is 0.8 miles from Augusta Road; thence S. 33-17 W. 212.39 feet to an iron pin; thence N. 67-35 W. 380 feet to an iron pin; thence N. 17-04 E. 133 feet to an iron pin; thence N. 41-27 E. 119.8 feet to an iron pin; thence N. 45-49 E. 70.4 feet to the point of beginning.



Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and all of the reads, issues, and profits which may arise or be had thereform, and including all heating, plumbing, and, lighting fixtures row or horeafter attached, connected, or fitted thereto in any manners it being the intention of the parties hereto that all fixtures in log-uppears, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its hoirs, successors and assigns, forever.

The Mortzazor covenints that it is lawfully seized of the premises herein above described in fee simple absolute, that it has cool right and is lawfully with rived to sell, convey or encumber the same, and that the premises are free and clear of all lines and encumbrances except as provided herein. He Mortzazor further covenints to wurant and forever defend all and simpler the said premises unto the Mortzazor forever, from and against the Mortzazor and all persons whomsever lawfully changed the same or any part thereof.
