In the event of any sale, conveyance or transfer that Mortgagor asserts to be within the criteria of subparagraphs (i) or (ii) above, Mortgagee shall not be liable for any monetary damages arising out of its failure to approve any such sale, conveyance or transfer by reason of a dispute between Mortgagor and Mortgagee as to
