ANT CONTACTOR OF THE STATE

In case of default in the payment of any part of the principal indebtedness, or of any part of the interest, at the time the same becomes due, or in the case of failure to keep insured for the benefit of the mertgagee the houses and buildings on the premises against fire and ternado risk, as herein provided, or in case of failure to pay any taxes or assessments to become due on said property within the time required by law; in either of said cases the mortgagee shall be entitled to declare the entire delation and to institute foreclosure proceedings.
