MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

All the certain piece/parcel for lot of lind, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, O'Neal Township, being known and designated as part of Lot 11 and part of Lot 12 of Paris View Subdivision, Section 1, as shown on plat thereof being recorded in the R. M. C. Office for Greenville County in Plat Book VV, at Page 101, and having, according to a survey prepared for J. P. Medlock by Jones Engineering Service dated September 27, 1974 and recorded in the R. M. C. Office for Greenville County in Plat Book 5-I, at Page 50, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of a County Road, which iron pin lies 300 feet southwest of Highway 415, and running thence with a new line through Lot 12, S. 39-22 E. 200 feet to an iron pin; thence S. 50-38 W. 125 feet to an iron pin; thence with a new line through Lot 11, N. 39-22 W. 200 feet to an iron pin on the southeastern side of a County Road; thence with the southeastern side of said County Road, N. 50-38 E. 125 feet to the beginning corner.
