All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot #323 on plat of Del Norte Estates, Section II made by Piedmont Engineers & Architects dated 5/22/71 and recorded in the RMC Office for Greenville County in Plat Book 4N at Pages 12,13. According to said plat, the property is described as follows:

BEGINNING -at an iron pin on Scottswood Drive (formerly Marchant Road) at the joint front corner of Lots 323 and 324 and running thence along the joint line of said lots S. 25-59 W. 147.8 feet to an iron pin; thence N. 75-19 W. 52.72 feet to an iron pin; thence N. 63-42 W. 42.28 feet to an iron pin at the joint rear corner of Lots 322 and 323; thence with the joint line of said lots N. 31-20 E. 159.4 feet to an iron pin on Scottswood Drive; thence with said Drive S. 58-29 E. 17.1 feet; thence continuing with said drive, S. 63-48 E. 62.1 feet to an iron pin, the point of beginning.
