All that piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, within the corporate limits of the City of Greenville, lying on the southwestern side of Beverly Lane, identified on the County Tax Maps as Sheet 274.4, Block 1, Lot 114, and having, according to a survey prepared for Thomas W. Barnhill and Dorothy Barnhill by Campbell & Clarkson, Surveyors, dated March 2, 1976, and recorded in the RMC Office for Greenville County in Plat Book at page , the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of Beverly Lane at the corner of property on which an Exxon sign is located and running thence with said line, S. 52-26 W. 160 feet to an iron pin in the line of property on which a Bonanza Restaurant is located and running thence N. 37-34 W. 10 feet to an iron pin; thence continuing with said Bonanza line, S. 52-26 W. 166.05 feet to an iron pin; thence N. 27-42 W. 60.9 feet to an iron pin in the line of Lot No. 5; thence along the line of Lots Nos. 5, 4, 3 and 6, N. 52-26 E. 315.5 feet to an iron pin on the southwestern side of Beverly Lane; thence with the southwestern side of Beverly Lane, S. 37-34 E. 70 feet to the beginning corner.

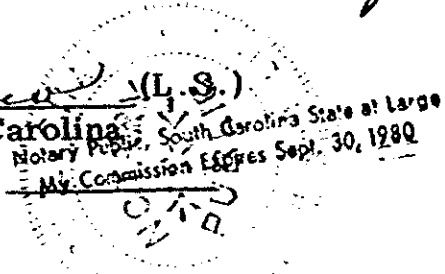
