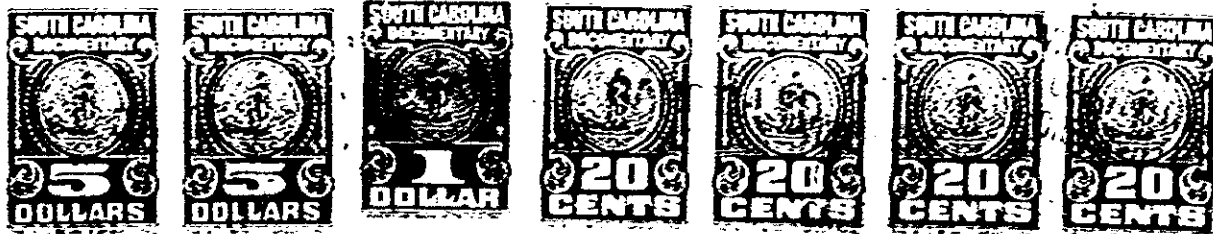
WHEREAS: George Patrick Throneburg and Joanne L. Throneburg
