

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the city of Greenville, on the Northwestern intersection of Sylvan Drive and Byrd Boulevard, being shown and designated as Lots Nos. 63, 64, and a portion of Lot No. 61 on a Plat entitled "Country Club Estates", recorded in the RMC Office for Greenville County, South Carolina in Plat Book G. Pages 190 and 191 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwestern side of Byrd Boulevard, joint front corners of Lots Nos. 62 and 63 and running thence S. 63-38 W., 200.4 feet to an iron pin in the line of Lot No. 60; thence running with the line of Lot No. 60, S. 23-22 E., 78.4 feet to an iron pin on the Northern side of Sylvan Drive; thence along the line of the Northern side of the said Sylvan Drive, N. 80-08 E., 51.4 feet to an iron pin; thence continuing with the Northern side of Sylvan Drive, N. 70-43 E., 151 feet to an iron pin at the intersection of Sylvan Drive and Byrd Boulevard; thence with the Northwestern side of Byrd Boulevard, N. 23-30 W., 100 feet to the point and place of beginning.
