TO ALL WHOM THESE PRESENTS MAY CONCERN:
CHARLES E. BUTLER BUILDERS, INC.

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of TWENTY NINE THOUSAND EIGHT HUNDRED -----

DOLLARS (\$ 29,800.00), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the southeastern side of Del Norte Road, being known and designated as Lot No. 73 on plat of Del Norte Estates recorded in the RMC Office for Greenville County in plat book WW at page 32 and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the southeastern side of Del Norte Road at the joint front corner of Lots 72 & 73, and running thence with the common line of said lots S. 51-07 E. 136.45 feet to an iron pin at the joint rear corner of said lots; thence S. 36-47 W. 95 feet to an iron pin at the joint rear corner of Lots 73 & 74; thence with the common line of said lots N. 51-07 W. 137 feet to an iron pin on Del Norte Road; thence with said Road N. 37-06 E. 95 feet to the point of beginning.
