EUGENE TYRONE ECKFORD and KAREN R. ECKFORD

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of ----- Eleven Thousand Five Hundred and No/100----- DOLLARS

(\$ 11,500.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is ten (10) years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference: and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southeastern side of Oregon Street, being shown as Lot No. 2, Block B, of Kanatenah Subdivision prepared by J. E. Sirrine Company, dated June 7, 1922, recorded in Plat Book F, at Pages 66 and 67, in the RMC Office for Greenville County and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Oregon Street at the joint front corner of Lots 1 and 2 and running thence with Lot 1, S. 26-30 E. 165 feet to an iron pin at the joint rear corner of Lots 1 and 2; thence N. 63-35 E. 60 feet to an iron pin at the joint rear corner of Lots 2 and 3; thence with Lot 3, N. 26-30 W. 165 feet to an iron pin on Oregon Street; thence with said Street, S. 63-35 W. 60 feet to the point of beginning.
