(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty-eight Thousand Three Hundred and no/100-----DOLLARS

(\$ 28,300.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is twenty-five years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

\*All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All those pieces, parcels or lots of land lying in the State of South Carolina, County of Greenville, shown as Lots 16 and 17 on plat of Oakland Terrace, recorded in Plat Book BB at page 196 and having according to said plat the following courses and distances:

BEGINNING at an iron pin on Duncan Chapel Road, joint front corner of Lots 17 and 18 and running thence with the joint line of said lots, S. 45-54 W. 187.3 feet to an iron pin, joint rear corner of said lots; thence along the rear line of Lot 17, N. 43-16 W. 100 feet to an iron pin; thence along the rear line of Lot 16, N. 43-16 W. 117.7 feet to an iron pin on Engel Drive; thence with said Drive, S. 50-09 W. 175.4 feet to an iron pin in curve of Duncan Chapel Road; thence with said curve, S. 84-51 E. 35.4 feet to an iron pin; thence along Duncan Chapel Road, S. 39-51 E. 75 feet to an iron pin and S. 43-16 E. 100 feet to the point of beginning.
