All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, hing and being in the State of South Carolina, County of Greenville, Town of Mauldin, being shown as Lot 6 on a plat of Bishop Heights Subdivision by Ethan C. Allen, dated January, 1966, and recorded in the RMC Office for Greenville County in Plat Book BBB at Page 171 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern edge of Bishop Drive at the joint front corner of Lots 5 and 6 and running thence with the line of Lot 5, S. 34-47 W. 225 feet; thence N. 55-13 W. 100 feet to the joint rear corner of Lots 6 and 7; thence with the line of Lot 7, N. 34-47 E. 225 feet to an iron pin on the southwestern edge of Bishop Drive; thence with the edge of said Drive, S.55-13 E. 100 feet to the point of beginning.
