That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, bying and being in the State of South Carolina, County of Greenville, lying and being in Greenville Township on the south side of Hilltop Drive and being known and designated as Lot 28 and the western three feet of Lot 29 of Shannon Terrace as shown on plat recorded in the RMC Office for Greenville County in Plat Book G, Pages 260-261, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at a point on the south side of Hilltop Drive at the joint corner of Lots 27 and 28 and running thence with Hilltop Drive N. 61 W. 53 feet to a point in the line of Lot 29; thence N. 29 E. 150 feet to a point in the rear line of Lot 29; thence S. 61 E. 53 feet to a point being the joint corner of Lots 27, 28, 34, and 35; thence with the dividing line of Lots 27 and 28, S. 29 W., 150 feet to the point of beginning.
