ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville and being more patricularly described as Lot 18, section B. as shown on a plat entitled "A Subdivision for Woodside Mills, Greenville, S.C." made by Pickell and Pickell, Engineeers, Greenville, S.C.
