WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty-four Thousand Four Hundred and no/100ths ----- DOLLARS

(\$ 24,400.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 25 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

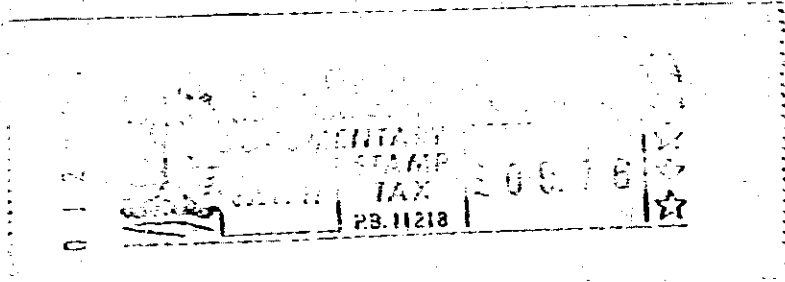

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the southwestern corner of Parker Road with Starsdale Circle, being shown and designated as Lot No. 1 on a plat of STARSDALE MANOR SUBDIVISION, made by Dalton & Neves, Engineers, dated March, 1956, recorded in the RMC Office for Greenville County, S. C., in Plat Book NN, page 9, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Starsdale Circle at the joint corners of Lots Nos. 1 and 2 and running thence along the common line of said lots, S. 21-25 E., 148.1 feet to a point; thence N. 80-45 E., 70.7 feet to an iron pin on the western side of Parker Road; thence with the western side of Parker Road, N. 4-58 E., 127.8 feet to a point; thence with the curve of the southwestern corner of the intersection of Parker Road with Starsdale Circle, the chord of which is N. 39-05 W., 30.2 feet to a point; thence along the southern side of Starsdale Circle, S. 82-38 W., 80 feet to a point; thence continuing along said side of Starsdale Circle, S. 68-35 W., 40 feet to the point of beginning.

The above property is the same conveyed to the Mortgagor by deed of Charles E. Wright and Leola R. Wright to be recorded simultaneously herewith.
