

That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars V(\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof 7 is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the 5 Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, hing hand being in the State of South Carolina, County of Greenville, on the southern side of Plantation Drive being shown as Lot No. 18 on a plat of Holly Hill Subdivision dated February 17, 1977 amended April 5, 1977 prepared by C.O. Riddle, Surveyor recorded in Plat Book 5-P at Page 85 in the RMC Office for Greenville County and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the southern side of Plantation Drive at the joint front corner of Lot 17 and Lot 18 and running thence with Plantation Drive, S. 17-32 E., 105.35 feet to an iron pin; thence S. 16-47 E., 185 feet to an iron pin at the joint rear corner of Lot 8 and Lot 18; thence with Lot 8 and Lot 9, N. 71-43 W., 192.4 feet to an iron pin at the joint rear corner of Lot 17 and Lot 18; thence with Lot 17, N. 11-06 E., 153 feet to the point of beginning.
