

NOW, KNOW ALL MEN, that we the said George A. Formoe and Gwendolyn F. Formoe in consideration of the said debt, and for the better securing the payment thereof, according to the conditions of the said Note; which with all its provisions is hereby made a part hereof; and also in consideration of Three Dollars to the said mortgagor in hand well and truly paid, by the said mortgagee, at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Domestic Loans of Greenville, Inc.

All that certain piece, or lot of land with all improvements thereon or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Highland Township, about one mile north of the Farm Creek Baptist Church on the south side of the Pack's Mountain Road, also known as Benton Road, containing in the acreage 8.1 acres and being shown on plat of the property of John W. Eggleston made by Harry C. Hill, PSC, dated November 25, 1974, recorded in the PSC Office for Greenville County, S.C. in Plat Book 4-0, pages 300 and 301, and having according to said plat the following notes and bounds, to-wit:

Beginning at a point in the center line of the Pack's Mountain Road at the corner of property owned by Sam E. Starns and running thence with the center line of said road, N. 25-00 E., 53 feet to a point in the center line of said road; thence along the line of property now or formerly owned by Border, S. 26-30 E., 302 feet to an iron pin; thence continuing along said line S. 07-30 E., 1020 feet to an iron pin; thence continuing along the line of said property S. 07-30 E., 100 feet to an iron pin; thence along the line of property owned by Sam E. Starns S. 22-13 1/2 W., 100 feet to an iron pin; thence N. 05-26 1/2 W., 225 feet to a point; thence on a curve around a private driveway the chords are N. 22-05 1/2 W., 70 feet, N. 09-12 1/2 W., 10 feet and N. 11-12 1/2 W., 30 feet to a point on the line separating a 1.2 from a 3.60 acres tract; thence N. 26-13 E., approximately 21 feet to a point on the line of said 1.2 acres tract; thence along the edge of said driveway N. 15-20 W., 165 feet to an iron pin; thence N. 06-12 E., 602 feet to an iron pin; thence N. 07-30 W., 161 feet to a point; thence N. 06-20 W., 115 feet to point of beginning.
