NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot 7 on plat entitled "Final plat, SHILOH ESTATES, Sec. 2", prepared by T. H. Walker, RLS, dated March 10, 1973, and having, according to said plat, the following metes and bounds, to-wit;

BEGINNING at an iron pin on the Northwesterly edge of Shiloh Lane at the joint front corner of Lots 7 and 8, which iron pin is locsted 193.8 feet, more or less, from the intersection of McCall Road and Shiloh Lane and running thence with the joint line of Lots 7 and 8, N. 79-50 W. 175 feet; thence N. 10-10 E. 214.3 feet to an iron pin at the joint rear corner of Lots 6 and 7; thence with the joint rear corner of said Lots, S. 79-50 E. 175 feet to an iron pin on the Northwesterly edge of Shiloh Lane at the joint front corner of Lots 6 and 7; thence with the Northwesterly edge of Shiloh Lane, S. 10-10 W. 214.3 feet to the beginning corner.
