ASSUMPTION AGREEMENT

This agreement made this 25th day of February , 19 78 , between South Carolina Federal Savings & Loan Association, a corporation chartered under the laws of the United States, hereinafter called the "Association," and Vern A. Peterson and Claudia C. Peterson hereinafter called the "Purchaser."

WITNESSETH:

Whereas, the Association is the owner and holder of a promissory note dated executed by Danco, Inc. June 21, 1976 and secured by a mortgage on the premises original amount of \$48,800.00 known and designated as Lot 37, 400 Piney Grove Road, Rt. 6, Greenville, SC, said mortgage being recorded in the R.M.C. Office for Greenville County, ; and also Loan at page South Carolina, in Mortgage Book Modification & Assumption Agm't recorded in Mortgage Book 1389 at page 738; and Whereas, the present owner of the aforesaid property desires to convey the same to the Purchaser who desires to assume the mortgage indebtedness and has requested the written consent of the Association to said transfer, pursuant to the aforesaid mortgage, which consent the Association has agreed to grant, provided the terms of the indebtedness are modified as hereinafter set forth.

NOW, THEREFORE, in consideration of the premises and the mutual agreements hereinafter expressed it is understood and agreed as follows:

- 1. The principal indebtedness now remaining unpaid on said loan is \$ 30,000.00 , the interest rate from the date hereof shall be 8.75 % per annum, and the said unpaid principal and interest shall be payable in monthly installments of \$ 265.11 each on the first day of each month hereafter until the principal and interest are fully paid; the balance of said principal and interest, if not sooner paid, shall be due and payable on the first day of _______ March _____, 19 98 _____.
- 2. All terms and conditions of the said promissory note and the said mortgage which it secures (which are incorporated herein by reference) shall continue in full force except as expressly modified by this agreement.
- 3. The Purchaser assumes and agrees to pay the indebtedness in accordance with the terms of said note and said mortgage as the same are modified by this agreement, and the Association hereby consents to the transfer of said property to the Purchaser and to said assumption.
- 4. This agreement shall bind the heirs, the executors, the administrators, the successors, and the assigns of the Association and of the Purchaser, respectively.
