WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, known and designated as Lot No. 27 of BROADMOOR Subdivision, as shown by a plat thereof recorded in the RMC Office for Greenville County in Plat Book RR at page 47, and having according to said plat the following metes and bounds:

Beginning at an iron pin on the western side of Holsby Lane, joint front corner of Lots 26 and 27 and running thence with the western side of Holmsby Lane S. 15-45 E. 50 feet to a pin; thence still with the western side of Holmsby Lane S. 5-10 E. 60 feet to a pin, joint corner of Lots 27 and 28; thence with the line of lot 28, S. 77-15 W. 139.6 feet to a pin at the rear corner of Lot 29; thence with Lot 29, N. 42-15 W. 65.9 feet to a pin, rear corner of Lot 26; thence with the line of lot 26, N. 68-03 E. 169.1 feet to the beginning corner.
