MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of

Three Hundred Sixty and 86/100----- 15 360.86) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable 25 years after date: and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collateral whole any proceedings and appropriate for the purpose of collateral principal due and payable, and said holder shall have the right to institute any proceedings upon said note and any collateral principal due and payable. erals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

NOW, KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (53.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE

ALL that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina being known and designated as Lot No. 32 of Devenger Place, Section 1, as shown on a plat thereof prepared by Dalton & Neves Co. dated October, 1973, recorded in the RMC Office for Greenville County in Plat Book 4X at Page 79 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Devenger Place at joint front corner of Lots 31 and 32 and running thence with the joint line of said lots, S. 48-18 E. 150 feet to an iron pin in line of property now or formerly belonging to Jesse F. Ward; thence along line of property now or formerly belonging to Ward, N. 41-42 E. 90 feet to an iron pin on line of Lot No. 34; thence along line of that lot and continuing along line of Lot No. 33, N. 48-18 W. 150 feet to an iron pin on the southern side of Devenger Place; thence along the southern side of Devenger Place, S. 41-42 W. 90 feet to beginning corner. This being the same property conveyed to the mortgagor herein by, deed of Daniel J. McCoy and Mary B. McCoy to be recorded herewith.
