14. That in the event this mortgage should be foreclosed, the Mortgager expressly waives the benefits of Sections 45-88 through 45-96.1 of the 1962 Code of Laws of South Carolina, as amended, or any other appreciaent laws.

## THE MORTGACEE COVENANTS AND ACREES AS FOLLOWS:

- I.
