"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot No. 241 on Plat of Del Norte Estates, Section No. 2, prepared by Piedmont Engineers and Architects, dated May 22, 1971, recorded in Plat Book 4-N at Page 13, and being described more particularly, to-wit:
