NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville**, containing **1.87 acres, more or less**, and being shown on plat of **Mae Davis Hill** recorded in the R.M.C. Office for Greenville County in Plat Book **MMM**, at Page **5** and having, according to said plat, the following metes and bounds, to-wit:

**BEGINNING** at an iron pin on the northwestern side of Berea Drive, at the corner of the Home Tract and running thence **N. 41-50 W. 408 (400)** feet to an iron pin; thence **N. 51-25 E. 200-feet** to a point in the center of the branch; thence along the center of the branch as the line, the traverse of which is **S. 40-30 E. 422 (414)** feet, more or less, to a point on the northwestern side of Berea Drive; thence with said Drive, **S. 60-50 W. 100-feet**; thence with said Drive, **S. 52-15 W. 100-feet** to the point of beginning.
