BEGINNING at an iron pin on the northern side of Gray Fox Square at the joint front corner of Lots 94 and 95 and running thence with the curve of the northern side of Gray Fox Square, the chord of which is S 32-21 W, 85 ft. to an iron pin at the joint front corner of Lots 95 and 96; thence running along the joint line of said lots N 66-34 W, 145.2 ft. to an iron pin; thence N 7-56 E, 153.7 ft. to an iron pin at the joint rear corner of Lots 95 and 94; thence along the joint line of said lots S 48-43 E 209.7 ft. to the point of beginning.
