"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 74 of ADAMS MILL ESTATES, according to a plat thereof by Dalton & Neves Company, dated June, 1972, and recorded in the R.M.C. Office for Greenville County in Plat Book 4-R at Page 31, reference to which plat is hereby craved for the metes and bounds thereof.
