ALL that certain piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, near the Ware Place, containing 4.41 acres, more or less, designated as Tract No. 8 on a plat of Section 1 of Hiawatha Subdivision, recorded in the RMC office for Greenville County in Plat Book 5-F at Page 86, surveyed by C.
