The estimated monthly premium for the first nine years will be .02% of the original amount of the loan. The estimated monthly premium for each year thereafter will be .01% of the original principal balance of this loan. The cortgage may advance this premium and collect it as part of the debt secured by the mortgage if the mortgagor fails to pay it."
