To Secure to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of ... ALL that piece, parcel or lot of land with all improvements thereon situate, lying and being in the County of Greenville, State of South Carolina, Paris Mountain Township, lying on the eastern side of Hiawassee Drive, being known and designated as Lot No. 53 of a subdivision known as Indian Hills as shown on a plat thereof being recorded in the RMC Office for Greenville County in Plat Book QQ, at page 11, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the western side of Hiawassee Drive, joint front corner of Lots Nos. 52 and 53 and running thence with joint line of said lots S. 80-30 W. 180 feet to iron pin in line of Lot 57; thence with said lot N. 9-30 W. 44.9 feet to iron pin at corner of Lot No. 55; thence with line of Lot 55, N. 41-30 E. 88.4 feet to iron pin at the corner of Lot No. 54; thence with line of Lot No. 54, N. 80-30 E. 111.2 feet to iron pin on western side of Hiawassee Drive; thence with said drive S. 9-30 E. 100 feet to the beginning corner.

The estimated monthly premium of the first nine years will be .02% of the original amount of the loan. The estimated monthly premium for each year thereafter will be .01% of the original principal balance of this loan. The mortgagee may advance this premium and collect it as part of the debt secured by the mortgage if the mortgagor fails to pay it."
