NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville:

TRACT NO. 1: ALL that piece, parcel or lot of land in O'Neal Township, Greenville County, S.C., near Berry's Mill and east therefrom, on Beaver Dam Creek, bounded on the north and east by lands now or formerly of Grover A. Hawkins, on the south by Tract No. 2 hereinbelow described, and on the west by lands now of formerly of B.C. Berry, containing 35.73 acres, more or less, having the following courses and distances according to a plat made by H.S. Brockman, Surveyor, dated February 9, 1937, to-wit:

TRACT NO. 2: ALL that other tract of land adjoining the above-described tract and lying on the south side thereof, containing 15 acres, more or less, bounded on the north by the above-described tract, on the east by lands now or formerly of Mrs. Junie Walls, on the south by lands now or formerly of the T.P. Fitts Estate, and on the west by lands now or formerly of B.C. Berry, and having the following courses and distances according to a plat made for S.C. Dickson by H.S. Brockman, Surveyor, dated February 19, 1934, to-wit:

Dickson's X; thence N 72-05 E 110.7 feet to a stake; thence N 4-26 W 223.2 feet to a stake; thence N 23-35 E 185.3 feet to a stake; thence N 55-10 E

Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
