All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the County of Greenville, State of South Carolina, near the City of Greenville, on the southwerly side of Hillsborough Drive, being known and designated as Lot No. 116 on plat entitled "Final Plat Revised, Map \$2, Foxcroft, Section II", as recorded in the RMC Office for Greenville County, S.C., in Plat Book 4-N, at pages 36 and 37, and having according to said plat the following metes and bounds, to-wit:
