

WHEREAS, Borrower is indebted to Lender in the principal sum ofFifty Four Thousandand no/100 (\$54,000.00) Dollars, which indebtedness is evidenced by Borrower's note dated _November 15, 1978, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable onNovember1, 2008;
TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of
ALL that certain piece, parcel or lot of land with improvements thereon, situate, lying and being in the County and State aforesaid on the southwest side of Merrifield Drive and being shown as Lot 136 on plat of "Merrifield Park", recorded in the RMC Office for Greenville County, S. C. in Plat Book 000 at Page 177 and having according to a recent plat and survey entitled "Property of William T. Adams and Nancy S. Adams" prepared by Freeland and Associates, Engineers, October 20, 1978, the following metes and bounds, to-wit:
BEGINNING at an iron pin on the southwest side of Merrifield Drive at the joint corner of lots 135 and 136; thence S. 55-42 W. 232.4' to an iron pin; thence N. 52-27 W 115.8 feet to an iron pin; thence N. 55-42 E. 268.5 feet to an iron pin on the southwest gide of said road; thence with the line of said road S. 34-18 E. 110 feet to point of
