

Citizens Building and Loan Association SEND GREETING:

WHEREAS, Bobby Joe Green and Sarah Melissa Green the said that certain promissory note in writing of even date with these Presents, in and by that well and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S.
