ALL that piece, parcel or lot of land, situate, lying and being in the County of Greenville, State of South Carolina, in Fairview Township, on the northern side of Nash Mill Road about five miles west of the Town of Fountain Inn, and being known as a 1 acre tract on a plat entitled "Property of Walter F. Walden", prepared by T. H. Walker, Jr., R.L.S., dated April 5, 1973, recorded in the RMC Office for Greenville County in Plat Book 6-W at Page 28 and being shown on a more recent plat entitled "Property of Larry O. Estepp and Polly A. Estepp", prepared by Carolina Surveying Company, dated November 16, 1978, recorded in the RMC Office for Greenville County in Plat Book 6X at Page 4C, and having, according to the more recent plat, the following metes and bounds, to-wit:

The Mortgagor covenants and agrees as follows:
