(6) That if there is a default in any of the terms, conditions, or covenants of this mortgage, or of the note secured hereby, then, at the option of the Mortgagee, all sums; then lowing by the Mortgager to the Mortgagee shall become immediately due and payable, and this mortgage may be foreclosed.
