WITNESSETH

Roosevelt Lister

that whereas Five Thousand Five Hundred Sixty-nine
and 73/100 \$5,569.73

whereas Roosevelt Lister

hereby conveys to Bankers Trust of South Carolina, before the 1st day of
January 1985, an undivided interest in the above described property, as per agreement made and
executed this day.

And whereas, upon and after the date of recording of this Mortgage, the above property of the
conveyed herein will be held by the Bankers Trust of South Carolina, as security for the payment
of the principal sum of \$5,569.73, and interest thereon at the rate of six percent per annum,
and attorney's fees, costs and expenses of collection, and all other expenses of the Bankers Trust of South
Carolina in the enforcement of this Mortgage, and the conveyance of the above property to the
Bankers Trust of South Carolina, and the payment of all taxes, assessments, and other charges
against the same, and the payment of all expenses of recording, filing, and advertising, and the
costs of the Bankers Trust of South Carolina in the enforcement of this Mortgage.

All that piece or lot of land in Oneal Township of Greenville County,
State of South Carolina, containing 5.11 acres, more or less, and having
the following courses and distances, to-wit:

BEGINNING AT an iron pin at a corner with the Lola Crain land and running
thence S. 80-15 E. 284 feet to a stone corner thence N. 42-00 E. 221 feet to a
stone corner of Carl Crain land; thence N. 30-55 W. 546 feet to an iron
pin; thence S. 33-05 W. 554.4 feet to an iron pin; thence S. 55-10 E.
311.6 feet to the beginning corner, bounded by lands now or formerly of
M. Ottis Hopkins, Brinnie R. Hopkins, Carl Crain, Lola Crain and others.

thence up the bank of Grace Meadow Road N. 17-35 W. 120 feet; thence N.
14-30 E. 131 feet to the above described property; thence S. 04-40 E.
150 feet to a point; thence S. 48-30 W. 275.5 feet to the point of beginning.
