

Section 11 of the National Housing Act provides that the Secretary of Housing and Urban Development may issue a certificate under the National Housing Act within **60 days** from the date upon which the holder of a certificate of the Department of Housing and Urban Development authorizes the Secretary of Housing and Urban Development dated subsequent to the **(same)** to enter on the date of the issuance of such certificate and note and this certificate being deemed conclusive proof of such authorization, the Secretary of the Department of Housing and Urban Development may issue all signs specified herein in the location and places.

It is agreed that the Mortgagor shall hold and enjoy the premises above described until there is a default under this instrument or in the notes secured hereby. It is the true meaning of this instrument that if the Mortgagor shall fail to pay all the terms, conditions, and covenants of this mortgage, and of the notes secured hereby, that then this instrument shall be declared null and void, otherwise to remain in full force and virtue. If there is a default in any of the terms, conditions, or covenants of this instrument or of the notes secured hereby, then, at the option of the Mortgagor, all sums then owing by the Mortgagor to the Mortgaggee shall become immediately due and payable and this instrument may be foreclosed. The Mortgagor waives the benefit of any appraisal laws of the State of South Carolina. Should any legal proceedings be instituted for the foreclosure of this mortgage, or should the Mortgagor become unable to pay sufficient money, this instrument, the title to the premises described herein, or should the debt secured hereby or any part thereof be placed in the hands of an attorney at law for collection by suit or otherwise, costs and expenses, including attorney's fees and Street incurred by the Mortgaggee, and a reasonable attorney's fee, shall thereupon become due and payable immediately, or, if so ordered, at the option of the Mortgaggee, one-half of the debt secured hereby, and may be foreclosed and collected hereafter.

The elements herein contained shall bind, and the benefits and advantages shall inure to, the respective heirs, executors, administrators, successors, and assigns of the parties hereto. Whenever used, the singular number shall include the plural, the plural the singular, and the use of any gender shall be applicable to all genders.


