by the Mortgagee, and also in consideration of the further sum of Three Dollars \$3.00 to the Mortgagor in hand well and truly paid by the
Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold
and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, the Mortgagee's heirs, successors and assigns:"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being
in the State of South Carolina, County ofall that piece, parcel or lot of land, in the County of Greenville,
State of South Carolina, being located in Section 11, Lot 11, in
the place of Greenville, State of South Carolina, in the Office
for Greenville County, S.C., in Block House Number 111, and having
having a frontage on the north side of the said Carolina Street of 20 feet,
a length of 112.0 feet on the west side, a depth of 112.0 feet on the
east side and a total width of 112.0 feet.Subject to the same, fully acknowledged to the County of Greenville and
any other liens or charges of record, I, Lorraine Holbrook, do hereby release the title
to the above described land to the said Mortgagee, and do hereby warrant and
covenant to the said Mortgagee that I have no right, title or interest in the same.I further covenant to the said Mortgagee that I will not in any manner
interfere with the title of the said Mortgagee to the above described land

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right
and is lawfully authorized to sell, convey or transfer the same, and that the premises are free and clear of all liens and encumbrances except
as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee
forever, from and against the Mortgagee and all persons whomsoever lawfully claiming the same or any part thereof.RV-21
