

In view of the above, and in accordance with the applicable provisions of the law, the Board has decided to accept the resignation of the General Secretary of the KPD, Dr. Auguste Macke, and to elect Dr. Walter Ulbricht as his successor.

B. Results The results of the study are presented in Table 1. The mean age of the subjects was 33 years and the mean body mass index was 25.2 kg/m². The mean systolic blood pressure was 130 mmHg and the mean diastolic blood pressure was 80 mmHg. The mean total cholesterol level was 210 mg/dL and the mean triglyceride level was 150 mg/dL.

and deposited in the account and all amounts so deposited shall be held by the Manger until paid at the due date of the next such payment, notwithstanding default under this Agreement. The Manger may at any time change the place of the bank where the account for \$1,000 deposit payment is to be kept on the 15th day of each month and the same may be held in another or different bank.

3. All the total of payments made by the Mortgagor under (t) of paragraph 2 preceding shall exceed the amount of payments actually made by the Mortgagor for taxes or assessments or insurance premiums, as the case may be, such excess if the same is unpaid, at the option of the Mortgagor, shall be credited on subsequent payments to be made by the Mortgagor, or referred to the Mortgagor. If however, the monthly payments made by the Mortgagor under (t) of paragraph 2 preceding shall not be sufficient to pay taxes and assessments and insurance premiums when the same shall become due and payable, then the Mortgagor shall pay to the Mortgagor any amount necessary to make up the deficiency, on or before the date when payment of such taxes, assessments or insurance premiums shall be due. If at any time the Mortgagor shall tender to the Mortgagor, in accordance with the provisions of the note secured hereby, full payment of the entire indebtedness represented thereby, the Mortgagor shall be compounding the amount of such indebtedness credit to the amount of the Mortgagor all payments made under the provisions of (t) of paragraph 2 hereof which the Mortgagor has not become obligated to pay to the Secretary of Housing and Urban Development, and any balance remaining in the funds so accumulated under the provisions of (t) of paragraph 2 hereof. If there shall be a deficit under any of the provisions of this mortgage resulting in a public sale of the premises covered hereby, or if the property is otherwise disposed after default, the Mortgagor shall apply, at the time of the commencement of such proceedings, or at the time the property is otherwise disposed, the balance then remaining in the funds accumulated under (t) of paragraph 2 preceding as a credit against the amount of principal then remaining unpaid under the note so secured hereby, and shall pay over to the person or persons whom it shall be lawfully delivered, under the provisions of paragraph 3.

3. That he will pay all taxes, assessments, water rates, and other governmental or municipal charges, fines or impositions, for which property has not been made responsible, and in default thereof the Mortgagor may pay the same and shall be entitled promptly to deliver the title to the property to the Mortgagor. If the Mortgagor fails to make the payments as aforesaid the Mortgagor shall be entitled to pay all taxes, assessments, or other charges, which may be levied against the property and shall be entitled to deduct the amount so paid from the principal sum due.
