

in consideration of the said debt and for the better securing the payment thereof do hereby make the conditions of the said Note; which  
with all its provisos to hereinafter make a full, clear and entire record of the same, do hereby make and bind well and  
truly paid, to the said payee of and before the date hereof, in the sum of the principal above, the sum of which is hereby additional-  
ed to have granted, bargained, sold and delivered, and by these presents do grant, bargain, sell and release unto the said  
Domestic Loans of Greenville, Inc.

All that lot of land in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 4 on plat of property of L. S. Hand, recorded in plat book J at page 146-147 of the RMC Office for Greenville County, S.C., and having according to said plat, and a recent survey made by J.C. Hill,  
October, 1963 the following metes and bounds, to-wit:

Beginning at an iron pin on the southeast side of Ackley Road, at the joint front corner of lots Nos. 1 & 2; thence with the joint line of said lots S. 36-05 E. 171 feet to an iron pin; thence S. 36-30 W. 81 feet to an iron pin corner of Lot No. 3; thence with the line of said lot N. 36-05 W. 187 feet to an iron pin on the southeast side of Ackley Road; thence with the southeast side of said road N. 65-15 E. 82 feet to the beginning corner.
