"ALL that certain piece, part or lot of land and all improvements thereon, or heretofore situated theron, situate, lying and being in the State of South Carolina, County of Greenville, near City View, as shown on a Plat entitled "Property of Lillie Laura Bennett", recorded in the RMC Office for Greenville County in Plat Book KK, at Page 122, said Lot being specifically described as follows:

BEGINNING at a point on the southern side of Marion Road and running thence along the line of Lot 70, S 32-02 E, 203.6 feet to a point; thence running S 51-42 W, 97.6 feet to an iron pin; thence running N 29-30 W, 164.3 feet along Lot 75 to a point on Marion Road; thence along the curve of Marion Road the chord of which is N 27-48 E, 100.3 feet to the point of beginning.
