Advances, if any, had no acceleration occurred, the Borrower cures all breaches of any other covenants or agreements of Borrower contained in this Mortgage, ter Borrower pays all reasonable expenses incurred by Lender in enforcing the covenants and agreements of Borrower contained in this Mortgage and in enforcing Lender's remedies as provided in paragraph 18 hereof, including, but not lumied to, reasonable atterney's feest and the Borrower takes such action as Lender may reasonably require to assure that the fiel of this Mortgage, Lender's interest in the Property and Borrower's obligation to pay the sams secured by this Mortgage shall continue unimpaired. Upon such payment and cure by Borrower, this Mortgage and the obligations secured hereby shall remain in full force and effect as if no acceleration had occurred.

20. Assignment of Rents; Appointment of Receiver. As additional security hereunder, Borrower hereby assigns to Londer the rents of the Property, provided that Borrower shall, prior to acceleration under paragraph 18 hereof or

22. Release. Upon payment of all sums secured by this Mortgage, this Mortgage shall become null and void, and I ender shall release this Mortgage without charge to Borrower. Borrower shall pay all costs of recordation, if any.

23. Waiver of Homestead. Borrower hereby waives all right of homestead exemption in the Property.
