Any deficiency in the amount of the payment shall entitle the lessor to sue for the amount of such deficiency plus interest from the date of the payment until judgment is recovered or default is declared. The Manufacturer shall collect all amounts due under this Agreement.

3. In the total of payments made by the Mortgagor under (b) of paragraph 2 preceding shall exceed the amount of payments actually made by the Mortgagor for taxes or assessments or insurance premiums, as the case may be, such excess, if the loan is current at the option of the Mortgagor, shall be credited on subsequent payments to be made by the Mortgagor, or referred to the Mortgagor.
