NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00), the Mortgagor is in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has created, incurred, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee its successors and assigns,

ALL that certain piece, parcel or lot of land, with all improvements thereon, hereinafter described therein, situate, lying and being in the State of South Carolina, County of Greenville, on Stanley Drive, near the City of Greenville being shown as Unit 74 on a plat of Harbor Town, recorded in the RMC Office for Greenville County in Plat Book SP at Pages 13 and 14, and being more particularly described as follows:

BEGINNING at a point at the joint front corner of Units 74 and 73 and thence running N 38-39 E 20.8 feet; thence turning and running S 51-21 E 68.8 feet; thence turning and running S 38-39 W 20.8 feet; thence turning and running N 51-21 W 68.8 feet to the point of beginning.
